CERTIFICATION FEE:

Contractor Discounts are available for registering a crew of four or more. Specs may require a minimum # of crew members to be certified to pre-qualify to bid pervious projects. **Minimum registration is three crew members/company.**

Most new specifications will require the NRMCA INSTALLER level (4 crew members) as the minimum level of qualification for Pervious Contractors. Contractor crew members with a CURRENT NRMCA "Technician" Pervious Certification should upgrade their Certification status to "Installer" by acquiring the additional Certification elements for "Installer" Certification as listed below.

Per ACI 522.1-13, the **Technician level DOES NOT apply to CONTRACTOR CREW members.** To meet new specifications requirements, upgrading to the Installer level is required. **++ A performance evaluation & pervious work history is required to obtain Installer status.** NRMCA "CRAFTSMAN" Certification remains available to Installer candidates with sufficient experience.

NRMCA Certification levels for Professional Pervious Concrete Contractor CREW MEMBERS

Achieving NRMCA Pervious "INSTALLER" Certification requires:

- ☑ Successful passage of the written exam (75%) **Technician level only as a single element**
- ☑ Complete the **INSTALLER** Pervious Performance Evaluation in conjunction with a project reference placement or scheduled during an anticipated pervious placement **AND**
- ☑ Provide documentation (**NRMCA PCC8 INSTALLER Application**) of successful construction of at least three pervious projects with a total cumulative area exceeding 10,000 sq. ft. **AND**
- ☑ Complete and submit summarizing completion of the above pervious project requirements.
- ☑ **NEXT STATUS UPGRADE LEVEL IS "CRAFTSMAN"- All of the above PLUS 1500 – 3000 hours of pervious work**

**** Pervious Placement & Equipment:** If a practice placement option is available, Pervious Concrete Contractor Examinees must participate in a practice placement using proper placing equipment as supplied by attending contractor companies. The practice should include proper use of equipment such as concrete or standard garden rakes, Static or Hydraulic "spinning" Compaction roller(s), tools used for compacting edges, wet cut jointing rollers, edging equipment, cross rollers and Visqueen. Standard concrete finishing tools may also be used, but only as they apply to Pervious concrete.
