

Association advocacy secures better member outcomes

- Freeze on NPDES Fees. No increase in S&G Permit Fees since 2019
- Manufacturing Sales Tax (MST) exemption on purchases including ready mix trucks, batch & aggregate processing equipment since 1995
- Defeated Mineral Severance Tax proposals.
- 2023 Construction Aggregates Economic Contributions to WA State - Overview of the significance of our products and industry in gross sales, tax contributions, employment numbers, jobs, and much more.
- 2021 2025 Member-derived comprehensive 3-year Strategic Plan outlines the Association's Advocacy, Education, Promotional, and Communication objectives.
- 2021 LTC The Association provided an effective alternative to the WA Cares Act through a private LTC insurance option to gain exemption from the state-mandated payroll tax. Over 320 members and their families benefited from this Association solution. The opportunity gave each member a choice, control, and portability for their long-term care coverage needs.
- COVID Crisis Led the industry with up-to-the-minute updates and communications on the Governor's & CDC's everchanging restrictions.

Legislative efforts

2018 - 2023 Priority effort

For the fifth straight legislative session, we defeated five bad sustainability bills. None produced any sustainability benefits, they would have created bad, costly, and complex processes and prescriptive mandates.

Sustainability Efforts

- Working with Climate Earth and NRMCA to help members secure an EPD development process for their facilities and products with independent 3rd party verified EPDs to help member companies compete in evolving sustainable specifications.
- EPDs will become a required key metric in project specifications for measuring carbon emission reductions and advancing our industry as a leader in EDPs.
- At the Legislature's request, we wrote and produced an EPD report on properly applying and implementing EPD deliverables that work and reduce emissions.
- Wrote and supported industry-authored Build Clean alternative to Buy Clean Buy Fair Bills
- The Association wrote and passed concrete and aggregate recycling bills and three House and Senate Capital Budget provisos supporting industry recycling.

to work against poor legislation policy impacting your and business. Defeated an attempt by the State Building code council to make prescriptive GWP limits on Concrete and Steel all commercial construction statewide.


The benefit of rules and provisions that did not pass

Since 1990, Direct participation in ECY NPDES permits renewals improving NPDES permits, Prevailing Wage, Ergonomics, and WSDOT specifications.

WACA Agency interactions improve permit compliance potential and less restrictive conditions, reducing cost.

- Reducing and improving the impacts of proposed rules and policies on your business. WACA works successfully with Ecology, the Department of Natural Resources, Labor & Industries, WSDOT, MSHA, and the Department of Revenue.
- Direct participation in S&G Permit renewals every renewal since 1990.
- Engaged in preventing Prevailing wage overreaching.
- WACA wrote and created the scope of work definition of truck and ready-mix drivers, resulting in a simple, concise, and narrow definition, and has served on Prevailing Wage Advisory Committee (PWAC) since 2000.
